Brief: Federal Communications Commission (FCC)

The Federal Communications Commission (FCC) may appear to be a functionally genocidal organization that needs to be replaced. Among tenable crimes against humanity:

- Enabling frequency devices at what the FCC recognized to be peak oxygen absorption, inhibiting respiration, which may lead to death with or without interim hook-up to a ventilator.[1]
- Enabling communications in the vicinity of brain function, letting covert agencies and military contractors operate brain-computer interfaces which citizens cannot block by any "jammer" without risk of police or FBI invading their premises.[2]

- **2.** The FCC can be replaced by say Frequency Health Assurance granting authorizations based on long-term safety data representative of real-life use, as voted by thousands of doctors after reviewing peer-reviewed test reports without any conflict of interest.
- **3.** Jamming equipment to offset deleterious frequencies, without long-term range, should be promptly legalized. Intentional harm as by interfering with aircraft communications upon takeoff or landing would be punishable separately.
