

Curated Excerpts of Will Filer's "NSA Mind Control and Psyops"

"The NSA's behavioral modification process starts with identification and qualification of the subject. The NSA used to choose subjects based on the subject's net present value to the agency in public visibility, financial resources, political clout, or other... reasons. Additional considerations are given to minimizing security risks of exposure, the subject's posthypnotic suggestibility index, the subject's intelligence and reasoning ability, moral and superstitious beliefs, and the subject's social status and the weakness of the subject's primary support groups (family). Now a recent report referenced in the March 26th Business section of the Orange County Register from the National Sleep Foundation reports that 40% of Americans are experiencing sleeping problems. This news could indicate that the NSA is broadening its influence to the greater public. As explained below in this document, ***the NSA always starts its behavioral modification process with REM Deprivation.***

"After selection, the subject is subjected to long periods of REM Sleep Deprivation and reinforced torturing posthypnotic suggestions that will breakdown the subject's will, confidence, self-reliance, and moral values. Meanwhile, the subject is increasingly isolated from their familiar and trusted peer groups causing the subject to experience depression, apathy, and ultimately social and financial failure.

"Nazi Subliminal Assailants" Mistaken for Tinnitus

"The NSA combines hypnosis and thought labels to interrogate people without the subject being aware of it. 'How can hypnosis be used?' you might ask. The subconscious mind operates at a speed of about 1200 to 1400 words per minute. This is many times faster than the conscious mind that operates at 250 to 450 WPM (words per minute). The posthypnotic script can be spoken at fast conversational speed approximately 250 WPM and a recorder or a computer speeds up the

message up to approximately 1200 to 1400 WPM. Remember what happens when you play a 33 rpm record at 78 rpm? The resulting voice sound like the old American cartoon characters the Chipmunks. This is only slightly past doubling (2X) the delivery speed. At speeds as high as 1400 WPM, the voices would sound like a high pitched chattering whine [mistaken for tinnitus]. Remember when the words "Drink Coca Cola" were written on one frame of a movie in a theatre back in the 1960s? The frame rate in movies is played at 30 frames/second. At 1/30th of a second the conscious mind could not recognize the message but the subconscious mind could read it clearly. The audience increased their Coca-Cola consumption by 65% that night resulting in the Federal Government prohibiting subliminal advertising." Covert agencies then rolled out this technology.

"The empty space between words is minimized and pitch rise is compressed and filtered. Repetitive sine waves are also removed from the phonetic element's acoustic wave train thus reducing the actual number of sine waves making up a word by 50% or more. This reduces the actual length of the time it takes the phoneme to be delivered prior to accelerating (speeding-up) the delivery (like fast forward). This helps the message to be played at higher speeds and reduces the subject's ability to recognize it as accelerated speech. The technique of using optimized digitally sampled and edited phonemes appended together to form words and then sentences structured as hypnotic suggestions can be termed ***'computer-simulated subconscious speech language'.***"

Editor's note: NSA violates targets in homes with computer-simulated subconscious speech language and incessant sleep deprivation for hypnotic or post-hypnotic receptivity (often alongside directed energy weaponry (DEW), frequency and consciously perceived directed audio assaults, hacking and poisoning including by carcinogenic chromium and neurotoxic barium sprayed by the US Air Force: see "Resources for TIs with relevant

references accompanying it). ***These activities flagrantly violate 4th Amendment rights to be secure in one's person against unreasonable searches, required for individualized sleep deprivation and all facets of in-home torture.***

"This modification of the phonetic elements, played at low volume, combined with the environmental background noise makes it very difficult for a subject to record the NSA message. Even if the subject were to effectively record the message, it is very difficult to filter (separate) the NSA's message from background noise. Then, reconstructing the missing sine waves from the acoustic wave train and slowing the message down to discern the actual content of the "posthypnotic" script with the conscious mind would be nearly impossible for the average citizen."

Editor's note: this program proliferated, and was publicly disclosed, by 1999. It can be presumed that all major countries now have this technology. The agencies prefer to deploy it against subjects maximally receptive to post-hypnotic suggestions, which means incessantly sleep-deprived. Subjects in these programs are exhausted for years; and when the agencies fail to achieve their objectives, the programs never end — until the agencies and personnel in these operations, or subjects, are dead. This is domestic terrorism unchecked, with the full support of perpetrators at the NSA and CIA, their accomplices at the FBI and DHS, the Senate, House, ODNI and White House along with the DoD and its contractors.

No Little Program: Widespread Terrorism

"With access to the FBI's Crime Information Center (CIC), we could find several thousand files having the characteristic patterns where the NSA had [violated] the individuals with their "Thought Control" technology."

Editor's Note: Assault Methods Expanded

That was by 1999. Then the NSA programs incorporated more insidious assault methods, often in conjunction with CIA-type programs including directed energy weaponry (DEW) assault and routinely USAF bombardment of

targets with neurotoxic barium ("10,000 times more toxic to your nervous system than lead" per a doctor for pilots spraying it out of Peterson Air Force Base in Colorado) along with chromium, EPA-considered carcinogen, verified in targets' environments. That renders all participants in such torture operations on US soil guilty of 4th Amendment violation with intent to kill, subject to death penalties under 18 USC § 241–242 let alone for complicity in treasonous poisoning of the populace. (Cover stories of weather modification, combating global warming or protecting against exotic attacks do not fly for spray of a potent neurotoxin and carcinogen.)

In these programs the NSA is clearly a cheating (constitutional rights shredding), thieving (by neural monitoring, violating 4th Amendment rights and, when it takes private neurological data for any public purpose, 5th Amendment rights), sleep-depriving terrorist organization in the business of sexual assault, IP theft and destroying lives. Sleep deprivation alone is deadly. This agency won't stand. Until it is obliterated, the NSA plays, as others may now play, Jesus/God, heinously:

The NSA Plays Jesus

"The NSA uses this technology to resocialize (brainwash) the US civilian voting population into 'Giving their lives to Christ' (giving up their personal will and civil rights to the NSA). Each subject is required to maintain a 'Personal Relationship with Jesus Christ' (following the precepts of the Bible and doing what is ordered by the NSA)."

The NSA "is convincing many subjects that Jesus is back on earth and directing them" (as the NSA plays Jesus in voice/dreams/signs).

"[T]he subject is unknowingly given hypnosis while the subject is completely awake and is tortured and punished with this hypnosis into a predetermined behavior by the National Security Agency.... [for] the subject's life-long goal of 'a personal relationship with Jesus Christ'" played by the NSA in voice, dreams and/or signs. The NSA seeks to keep targets in an exhausted state for hypnotic receptivity.

"After a while [incessant sleep deprivation, other torture and NSA efforts to isolate the targeted individual or TI], the subject has an emotional breakdown and a new support group is built around the subject. The new support group is typically a church with doctrines centered in the Bible but the NSA also uses cults and other social groups. The NSA prefers Christian churches because the doctrines allow 'God or Jesus [the NSA] to speak directly to the subject'.... [T]he subject experiences a religious awakening and 'Gives their Life to Christ' and the NSA achieves total control of the subject."

After letting itself be controlled by the NSA playing Jesus: "The subject is slowly released from the damaging uncomfortable hypnosis and it is replaced with positive rewarding hypnosis as 'God and Jesus works in their life'. **Soon, the subject has complete loyalty to Jesus (AKA: NSA) and will do anything on command from Jesus (NSA).**"

"The subject is required to give daily status reports in the form of prayers in the privacy of their home, office, or car where the NSA's electronic surveillance system captures and sorts the prayers by 'Keywords'. The NSA then delivers additional hypnosis in the form of punishments or rewards or directs the subject accordingly to 'God's will'. **If the subject resist's the NSA's instructions, additional punishments are inflicted on the subject.**"

Editor's note: covert agencies that have acted as terrorist organizations, in our homes, are to be legally terminated along with accomplices in their terrorism, including censors of any of this publicly disclosed information.

"A subject that... completed the NSA's behavioral modification program lives out the rest of their mediocre life in service to Jesus (NSA) and never causes any waves in the church or news media for fear of reprisal from the NSA. The subject's lives are relatively unproductive because their focus is on their 'Life after death' and not what they accomplish while they are alive. They avoid 'worldly activities' and usually are confused and

disjointed in rational thoughts and concepts. For instance, they don't believe in anything that is not in the Bible... even though they ride on airplanes and watch television, both of which are not referenced in the Bible."

Isolation and Back-Stabbing People

Editor's note: covert agencies use Biderman's Chart of Coercion, which starts with isolation. They took out my cell phones, even took out my landline; they've crashed internet in response to my activity and assaulted others in my presence. After I talked with one woman, for example, a helicopter followed her and gave her back spasms while she was driving in the evening. Everyone in these operations will be legally exterminated, and the agencies of treasonous terrorism will legally die.

"After selection, the subject is subjected to long periods of [editor's note: interminable] REM Sleep Deprivation and reinforced torturing posthypnotic suggestions that will breakdown the subject's will, confidence, self-reliance, and moral values. Meanwhile, the subject is increasingly isolated from their familiar and trusted peer groups causing the subject to experience depression, apathy, and ultimately social and financial failure."

With "emotional isolation, the subject is susceptible to the approaches of **insincere people, which are used by the NSA to emotionally hurt the subject more. This allows the NSA to convince the subject that people can't be trusted and that only the NSA (Jesus) can be trusted.** This serves to isolate the subject from supportive peer groups and makes the subject emotionally dependent on the NSA [playing Jesus in voice, dreams and signs] resulting in the NSA gaining more power in the subject's life."

Heinous Interference with Family

"[W]hen the NSA wants to isolate the subject from the company of a specific person, place or thing, the subject will be implanted with a feeling of increased anxiety, hostility, tension, simple discomfort, or a feeling of a lack of

peace. When the subject leaves the person, place, or thing, another posthypnotic implant is triggered that rewards the subject's behavior with a feeling of relief from the anxiety, hostility, tension, discomfort, and peace is restored in the subject's mind."

Editor's note: I've heard this described firsthand. Personnel in these NSA operations have been monsters, intentionally breaking up families while destroying targets' lives, generally accompanied by sexual assault and/or intellectual property theft, all from violating the sanctity of minds and homes. In violating 4th Amendment rights, the agencies have had not even *one* honorable employee who upholds the 5 USC § 3331 oath in domestic operations.

Brief Cessation of NSA In-Home Assault

"Complete Quiet Silence: Used by the NSA as a positive reinforcement for two general reasons; the subject has the tinnitus [NSA subliminal messaging or posthypnotic implant] removed to indicate that the subject has 'The Lord's Peace Restored', and secondly, the subject has achieved a milestone toward being released by God (the NSA)." **NSA "rewards" targets by temporarily ceasing its assault.**

Editor's note: I experienced this twice in the last year: once briefly as a sick joke, after which my middle finger was electrocuted, and once for a night after I talked with an NSA asset in TX, where operatives wanted to lure me. (I've been followed in FL and MA by TX plates, several affiliated with Texas A&M, an agency recruiting center. It's been said that if you want to find the most anti-patriotic, constitution-shredding ideological Nazis who are idiotic enough to subject themselves to federal death penalties in agency-affiliated operations, hire from Texas A&M. That's where morally bankrupt students applauded Pompeo's reflection, "we lied, we cheated, we stole." He could have added "we raped, we murdered" a la his agency's George White's letter to Sidney Gotlieb: "Where else could a red-blooded American lie, kill, cheat, and rape with the sanction of the all-highest?")

Editor's Note: Conclusion

The NSA's violation of citizens in our residences shreds 4th Amendment rights in conjunction with neurotoxic barium and carcinogenic chromium spray over targets' locations by the US Air Force, unreasonably searching targets for this purpose. All involved in these operations violate constitutional rights with intent to kill. That is punishable by death under 18 USC § 241-242 — it is also treason. The NSA will be legally exterminated as a treasonous organization of terrorists.

Everyone supporting these operations may be legally extinguished accordingly. For modest reiteration, that includes every agency asset censoring any of this information, including in social media, including Facebook and Twitter.

The NSA will furnish all its targets full details of: all subliminal scripts used against them and their families and associates, hacking of their equipment and violation of their homes. Any NSA personnel who attempt to obfuscate this information face prosecution for execution, as does any politician tolerating covert agencies that are now treasonous terrorism operations.

I am posting this after being sleep-deprived by subliminal messaging amid other assaults, shot with directed energy weaponry (DEW) within one minute of rising, sodomized with searing pain multiple times within 5 minutes of rising and later in the morning, shot recurrently in my back and head, including while standing in the restroom and sitting at work, assaulted with frequencies causing internal rumbling, clicked by my ears and electrocuted in my extremities. This is with a runny nose like clockwork after USAF spray measured to include carcinogenic chromium and neurotoxic barium ("ten thousand times more toxic to your nervous system than lead" per a doctor for pilots spraying it out of Peterson AFB, it bears repeating): this is treason. Everyone supporting any facet of these heinous agency operations, turning our homes into WWII-style concentration camps with gassing and burning besides sleep deprivation and subliminal etc. assault, faces death penalties under law.
